

**Notice regarding the Status of Share Repurchase  
(Share Repurchase under Article 165 (2) of the Companies Act)**

**September 2, 2022** – At the Board of Directors held on March 10, 2022, Sekisui House, Ltd. resolved on matters relating to its share repurchase under Article 156 of the Companies Act, as applied pursuant to Article 165 (3) of the Companies Act. The status of the share repurchase is as follows.

1. Type of shares repurchased: Common stock
2. Number of shares repurchased: 2,719,500 shares
3. Price of shares repurchased: 6,376,287,121 yen
4. Period for repurchase: August 1, 2022 to August 31, 2022 (contractual basis)
5. Method of share repurchase: Repurchased through the Tokyo Stock Exchange

  - (1) Aggregate number of shares repurchased: 10,892,000 shares
  - (2) Aggregate price of shares repurchased: 25,320,045,671 yen
