



July 17, 2009 – Sekisui House, Ltd. ("the Company") hereby announces that the Company will undertake three housing development projects in Homebush Bay, Camden Hills and Ripley Valley in Commonwealth of Australia, by developing and providing residential areas as well as "SEKISUI HOUSE" home, a detached house and lot for sale. Details are as follow.

1. Reason for Entering Business:

The Company has conducted research on housing business circumstances in several countries, in order to make the most of the Company's know-how of long years regarding creation of high-quality house and residential environment worldwide. To launch global business development, the Company decided to take the initiative in entering the housing industry in Australia, where growth of population is expected and business environment, such as logistics, is well-organized as a developed country. (Some projects are joint ventures with Payce Consolidated Limited, a local leading property developer.)

In developing lands and houses, the Company will actively engage in grand design adopting Australian climate, culture and tradition, and develop and provide residential areas, and sell "SEKISUI HOUSE" homes, which will embody high property value for future.

"SEKISUI HOUSE" home, a detached house and lot for sale, has already been appreciated in Japan, and the Company believes that newly building high-performance and high-functional houses based on the use and application of the original expertise in "SEKISUI HOUSE" homes will enable the Company's house to differ from other local detached houses in terms of, among other things, security, environmental consideration and economy. Accordingly, the Company plans to carry out business in Australia.

With regards to the Homebush Bay project, 1,344 units of condominiums have already been provided, and the area is highly appreciated as excellent residential area.

2. Outlines of Business Development:

In each project of Homebush Bay, Camden Hills and Ripley Valley, the Company will sell approximately 6,600 lots in total, consisting of approximately 4,000 houses of 2,000 "SEKISUI HOUSE" homes, detached houses for sale, and 2,000 condominiums for sale, and additionally lots for sale over ten years from now.
