



**Notice regarding Share Repurchase
through Off-Auction Own Share Repurchase Trading (N-NET3)**

September 9, 2019 – Sekisui House, Ltd. (the “Company”) hereby announces that it has determined specific method of share repurchases under Article 156 of the Companies Act, as applied pursuant to Article 165 (3) of the Companies Act which was announced in September 5, 2019, as detailed below.

1. Method of share repurchase

The Company will place purchase orders for its own shares through Off-Auction Own Share Repurchase Trading (N-NET3) of the Nagoya Stock Exchange at 8:45 a.m. on September 10, 2019 at the closing price that may include the final special quote of today (September 9, 2019) of 1,999.0 yen (there will be no change to other trading methods).

2. Details of share repurchase
